Dear KIPP Philadelphia Preparatory Academy Community,

As a part of KIPP Philadelphia Schools effort to provide students and staff with safe and accessible drinking water, 12 water outlets at your school were tested for lead on September 1, 2023. A trained technician collected samples from water outlets and the samples were sent to an accredited Pennsylvania laboratory for analysis.

Test results showed all outlets were found to have no detectable lead in water. As such no further action is necessary to provide safe drinking water to our students and staff. If there are any further actions taken on our part, more information will immediately be sent to you.
